OLCOTT HARBOR BREAKWALL PROJECT - This project is approx. 95% complete. We will be installing a new waterline around the west block of Ontario St. during the winter and then, in the spring all the roads will be repaved. I would like to thank Sevenson Construction for the great work they did on this project and all the residents that endured the truck traffic, noise and dust throughout the project. This project will protect the harbor from the destructive wave action and will allow for much needed economic development of the Harbor area.

WEST BEACH BERM & INNER HARBOR CONTAINMENT WALL — These other two REDI projects should be ready to go in the spring of 2022. It has been a challenge to incorporate all these projects, as certain things have to be done at certain times. However, I think we have it all worked out so that when complete, they will do what they were intended to do: protect the lake shore area from flooding while allowing for economic development to occur.

As our community is aware, record high lake levels have become a reoccurring trend, and while the Federal Government is still working to reverse the impact of Plan 2014, New York State must continue to fortify our shoreline and improve our infrastructure to better protect our municipal assets, residents, and businesses from the rising levels of Lake Ontario.

Decades in the making, the Olcott Breakwall project moved forward and became reality in October 2019, and I was proud to join State Senator Rob Ortt in delivering funding for a myriad of projects that will help correct long-standing erosion and flooding problems along the entire Lake Ontario shore in Niagara County.

Tim has been a leader in Niagara County for decades and on behalf of our entire community, I want to thank him for his service and commitment to our county and town. It is very fitting that a plaque in his honor will be placed on the Outer Breakwall Project.

A message from our Niagara County Sheriff's Office



The Niagara County Sheriff's Office prides itself in offering a wide variety of services to the community, outside of traditional Law Enforcement practices. Our affiliation with many programs and services can be utilized by our residents in many ways.

NY-Alert is a web based portal that allows residents to sign up for emergency alert information and private notifications. Sign up for NY-Alert today to receive real-time warnings and emergency information directly via a phone call, email, text message or fax. You can sign up for NY-Alert at alert.ny.gov

With school back in session, the Niagara County Sheriff's Office reminds you of the Offender Watch Program. This free program is offered by NCSO which will give you real-time updates of sex offenders who reside in your community. Our children's safety is a priority at NCSO and we urge all parents to sign up. Sign up at https://communitynotification.com/cap_main.php?office=54113

One concern many people have is the security of their house while they are away on vacation. The Sheriff's Office regularly makes checks on houses and property all around Niagara County and we will gladly check on your house as part of our patrol in the Town of Newfane. It is reassuring to know that we have your back and will keep an eye on things when you are unable to. If you would like a check of your property while you are away, please call the main dispatch number, (716) 438-3393, to speak to a professional dispatcher and give the information for your house checks. Along the same lines is the security of our most highly valued items like our cars and recreational vehicles. I want to encourage each of you to remember to lock your car doors and remove all valuables from your vehicles when you have gone into your house for the night. If you have to leave anything of value outside while you are not there, make sure that you have secured it with a chain or some other device that will prevent it from being stolen. Our deputies are on the streets all the time but some simple steps like this may prevent you from becoming the victim of a crime.

In addition to these services, we have GPS bracelets available for vulnerable adults and children. If you are in need of this service, you can contact the NCSO Community Services Division at (716) 438-3310 to discuss your need and come up with a plan to help you through this process.

We also have a number of trained child safety seat technicians. The child safety seat technicians can inspect your child safety seat and give instruction on how to properly install this valuable safety item in your vehicle. Traffic Safety Educator Cathleen Davis can be contacted at (716) 438-3464 to arrange a car seat install or safety check.

One additional program I would like to make you aware of is the Yellow Dot Program. This program is designed to give first responders critical information about you and your family in the event of an accident or emergency in your house. When the yellow dot is located on your vehicle or house by a first responder, they know to look for important information, compiled by you, to assist in your family's medical treatment or conditions. Information regarding this program as well as packets to get you started can be obtained by contacting the NCSO Community Services Division at (716) 438-3310 or by visiting the Newfane Town Hall.

Of course these are just a few of the services that are provided by the Sheriff's Office. All of our posts and press releases can be followed on social media. I encourage you to browse our website and Mobile App to stay connected!

In other updates, we have hired a Special Deputy tasked to Pistol Permit Investigations. This should significantly expedite the pistol permit application process for pistol permit applicants in Niagara County.

It's important to remember that on October 24th 2021, 10-Digit Dialing went into effect for local calls.

This transition is needed due to the new designation of 9-8-8 as the Nationwide three-digit Suicide and Mental Health Crisis Lifeline which will be effective on July 16th 2022. Any area code with the 988 prefix must be transitioned to the 10-digit dialing to ensure everyone is able to reach the new crisis lifeline. Emergency services here in Niagara County and nationwide will not be disrupted. Residents will still be able to reach services using 9-1-1. Other services such as 4-1-1 will also be available as before.



STAR CHANGES NEW HOMEOWNERS/NEW APPLICANTS ONLY!!!

**NEW STAR applicants need to register with the New York State Tax Department. You will receive a check directly from New York State instead of receiving a school property tax exemption. Visit www.tax.ny.gov or call (518) 457-2036.

Enhanced Star Exemption (Current Basic STAR exemption recipients ONLY)

If you are over 65 or turning 65 years of age by December 31, 2022, you may qualify for the Enhanced STAR Exemption if your Adjustable Gross Income for 2020 was \$92,000 or less. This exemption will be applied to the upcoming 2022 assessment roll. To file for this exemption, the following items are needed: (1). Proof of age, (2). A copy of your 2020 Income Tax, (preferably NY State), and (3). Proof of your New York State residency. If you feel you qualify, contact the office no later than March 1, 2022 to file your paperwork.

***NEW MANDATORY for all ENHANCED STAR applicants. An RP-425-IVP must be submitted when applying for the Enhanced STAR exemption. Failure to do so will result in denial of the Enhanced STAR exemption.

**NEW YORK STATE DEPT. OF TAXATION AND FINANCE WILL MAIL INCOME WORKSHEETS AND COVER LETTERS TO HOME-OWNERS ONLY WHEN THEY NEED MORE INFORMATION TO DETERMINE ELIGIBILY FOR STAR. IF YOU RECEIVE INFORMATION PLEASE FOLLOW DIRECTIONS AND RETURN TO NEW YORK STATE. IF YOU DO NOT RECEIVE ANY CORRESPONDENCE FROM NEW YORK STATE YOU WILL CONTINUE WITH THE STAR EXEMPTION.

Order Hometown Hero Banners for Newfane Veterans



The Olcott Beach Hotel Story and the Origin of Krull Park

The hotel and trolly years in Olcott of the early 1900s are by far the best known and most photographed time in Newfane's history. Tens of thousands of visitors came to Olcott each summer and the period was particularly well documented because it coincided with the popular picture post-card era. Photos and stories abound about the Olcott Beach Hotel and it's often mistakenly said the hotel's end came when it burned down - but the story is far different, it was demolished in 1937 due to changing economic conditions and underlying structural deterioration. There were three fires in the hotel's 37-year history, but they were minor and quickly extinguished and the hotel continued operations until it was no longer profitable.

What we know today as the lakeside portion of Krull Park was private property through the 1800s and commonly referred to as the Pine Grove. As early as 1871, newspapers reported that Olcott was becoming a popular summer leisure and recreation destination and one of the three homes on the pine grove site, the Tenbrook cottage that was located along Franklin Street across from today's Mariner's Landing, was converted to a hotel called the Grove House and Lakeshore House. Tenbrook allowed his property to be used for picnics and outings and the Niagara County Pioneer's Association held their annual summer gatherings in the Pine Grove beginning in 1878. Travel was principally by rail in this pre-automobile age and railway executives of the day recognized the opportunities associated with building destination resorts that were served by rail lines and hotels they operated. Prominent Newfane resident, Burt Van Horn, Jr., was a leader in regional electric railway development and with other investors he formed the Lockport and Olcott Railway Co. that purchased the Pine Grove and surrounding property in 1899. The company started construction of the Lockport-Olcott trolly that year and the next year they merged with the International Railroad Co. (IRC) where Van Horn was General Manager and began construction of the Olcott Beach Hotel in 1900. The trolley connected Olcott with a network of rail lines already in place across the region that brought a steady stream of leisure travelers to the hotel from Lockport, Buffalo and Niagara Falls.

In the first two decades of the 1900s Olcott was heralded as one of the region's premier places for vacations, summer outings and cottage activity. There were numerous other hotels, restaurants and amusements in the village and steamships would bring passengers to the harbor from Canada, Rochester and Oswego. The IRC also built The Rialto amusement park in 1912 where today's park crossroad from Main Street to Route 18 and the Memorial Tree Garden are located. By the mid-1920s, however, the growth and popularity of the automobile began to influence leisure travel preferences and reliance on the railways and destinations like Olcott they served were changing. As hotel business dwindled and there were fewer trolly passengers, the IRC closed and demolished The Rialto amusement park in 1925.

The grand five-story Olcott Beach Hotel with more than 100 rooms remained in business for several more years, but as it entered its fourth decade the great depression further impacted leisure travel and the wood frame hotel erected on the water's edge had rotting structural deterioration. In its final years, most of the lodging rooms had been closed and only the bar and dance hall remained in operation. There was a small kitchen fire in 1923 that was quickly extinguished and in 1933 there was an explosion, but no fire, and in 1936 a minor fire caused by careless smoking was put-out by employees. The IRC demolished the hotel in 1937 because of declining business, its deteriorating condition, high fire insurance rates and to avoid paying further taxes. The Lockport-Olcott trolley had a slightly longer lifespan because it transported agricultural and commercial products, but the IRC ended passenger service in 1937 and removed the trolley in 1939.

The IRC offered to sell the property to Niagara County which was considering sites to develop a county park, but county leaders from Niagara Falls and the western towns favored the Bond Lake area near Sanborn. This prompted Frederick Krull, a Niagara Falls banker and Niagara County civic and political leader to step forward and purchase the IRC property, which he then donated to the county two-days later. Krull was a generational member of the Niagara County Pioneer's Association that his father helped organize and he wanted to preserve Olcott's pine grove and its beauty for Pioneer Association events and public use. The county accepted the offer and Olcott resident, Richard L. Rutland (1907-1967), was named the County's first Park's Commissioner and led the development of Krull Park beginning in 1938. The walls that define the terraced area of today's Krull park are stone brought from quarries in Lockport during park construction, but these walls are placed on the original footprint of the Olcott Beach Hotel foundation. Stone that was part of the Hotel's actual foundation can still be seen on the southeast wall of the terraces below the park. Today's Krull Park includes the terrace and beach area which are now owned and maintained by the Town of Newfane and the park areas above the lake on both sides of Route 18 are owned and preserved by Niagara County.

Tax Office Update:

The Niagara County/Town of Newfane tax bills will be mailed at the end of 2021 and are due and payable upon receipt. Please review your bill and if there seems to be a great difference from prior years, compare the items listed to determine where the changes have occurred. Feel free to call our office if more information is necessary.

Are You a NEW PROPERTY OWNER?

Some information you may not be aware of:

- When purchasing a new home the buyer is responsible for property taxes from the time of signing.
- Property and school taxes are forward taxes and are usually prorated by the attorney for the buyer at the time of purchase.
- Whether or not a tax bill is provided to the homeowner, it is still the responsibility of the new homeowner to become informed as to what taxes are due, the time frame that they are due in and the payment thereof.
- If a mortgage company holds money in escrow for taxes, it is best to make sure that the mortgage holder is paying the taxes in a timely fashion. If a receipt is not received from my office shortly after the penalty free period is over, the property owner should contact their mortgage company.

For the PROPERTY OWNER who no longer has a mortgage:

- The property owner is now responsible to pay the school and property taxes on their own and by planning ahead for this expense penalties can be avoided.
- School taxes are due in September without penalty and Town and County taxes are due by January 31st without penalty. School taxes unpaid by October 31st will appear on the Town and County bill for the following year and a penalty is included.
- Information is available at the Assessor's office for the Enhanced Star program. This reduction is based on income and must be applied for yearly.

The Tax Office staff is always willing to help you and answer your questions.







All the members of the Miller Hose Fire Company wish to offer a sincere Thank You to retiring Newfane Town Supervisor Tim Horanburg. Tim has been a strong supporter of the Town's volunteer fire service for many years while in office. He, along with the other members of the Town Board have always provided sound insight and guidance in the establishment of fire contracts and other matters involving the fire company. As Supervisor, Tim was very instrumental in converting what was our old firehall into what is now our Town Hall and Community Center located on Main Street. We wish Tim well in retirement and good fortune in any endeavor he may undertake.

Once again, winter weather months are upon us. Chief Coleman would like to remind everyone that may be heating their residence by burning wood, pellets, propane or natural gas, to check that their chimneys or exhaust ducts are not blocked and are clear of creosote buildup. For vented furnaces make sure vents are clear of any obstructions. This may include checking the outside buildup of drifting snow during storms. When using utility heaters for added warmth, ensure that the surrounding area around the unit is free from clutter and unit is in good working condition. Do not connect heaters to underrated household extension cords as they are not designed to handle the voltage required for the efficient use of the heater. With the winter months and what comes with them while traveling, it is recommended that you maintain a winter survival kit in your car or truck in case you become stranded. Blankets, a small shovel (for cleaning around the car's exhaust pipe), mobile cell phone/charger along with energy bars are items to be considered in the kit. Above all, always be aware of your surroundings, location, and visible landmarks to aid agencies to locate you if needed. Also, always try to maintain at least a half tank of gas in your vehicle, or now with EV vehicles becoming more in use, a full charge. Above all, drive to the condition of the road and weather.

Year to date, Miller Hose has responded to approximately 650 EMS medical emergency calls in conjunction with 117 fire, accidents, mutual aid and related service calls.

The Company would like to thank all those that donated to our Boot Drive that was conducted this fall during the Newfane Historical Society Harvest Day Festival. Monies collected will go to maintain or purchase new equipment for fire company personnel.

Chairman Dave Hoffman and his committee reported on another very successful Gun and 4-Wheeler raffle held this past September at finally a long awaiting actual open gathering at the fire hall. A total of 30 prizes which included the top prize of a Polaris 4-wheeler were awarded to happy winners. Many side raffles were also held during the day. Food was also provided to those in attendance. The committee would like to thank all those that purchased tickets to make this a very successful event.

During the first week of October's Fire Prevention month Miller Hose, Olcott and Wrights Corners Fire Companies were able to conduct the annual Fire Prevention Program in person for the students of Newfane's Elementary School grades K-3. The Town's Fire Prevention demonstration trailer was put to good use in showing and teaching the students in the different aspects of fire safety. Talks and demonstrations were done at the school and at the fire hall. A new twist to the teaching was the use of cell phones for calling 911. As the presence of telephone land lines in homes has decreased, the use and availability of cell phones has increased to make a call during an emergency more critical. The fire personnel from the 3 companies all agreed that it was fun getting back to a face to face and hands on interaction with the kids.

During the month of December, the fire company will be accepting nominations for officers of Miller Hose that will lead the company in 2022. Voting for those nominated will be held on the first Sunday of January 2022 at the Company's fire meeting. The formal installation of officers elected will be at the annual Installation Banquet on January 22nd.

To counteract the winter blahs, set aside the date of February 12th, 2022. The Company will be hosting its Annual Meat Raffle. Doors will open at 6pm at the firehall and the raffle will start at 7pm. Snacks and drink will be available. Presale tickets for meat prizes will also become available from any member of the Company.

By law, all cats, dogs and domesticated ferrets must have a current rabies vaccination from four (4) months of age and on.

Cats and dogs receiving immunization WITHOUT PROOF of a previous rabies immunization will receive a certificate valid for only one year. Cats and dogs WITH PROOF of a previous rabies immunization will receive a certificate valid for three years.

Ferrets must receive vaccinations annually, regardless of previous immunizations.

Clinics are FREE OF CHARGE to animals owned by Niagara County residents.

ALL ANIMALS must be properly restrained.

Cats and Ferrets must be in a box or carrier. Dogs must be leashed.

The Department does not offer dog or cat vaccinations other than rabies. It is very important for the health and well being of your animal and the other animals attending our rabies clinics, that they have seen a veterinarian and are up to date on all of their immunizations, to include dog parvo virus.



Here is a quick list from the American Kennel Club of some human foods your pets need to avoid. Anything containing grapes, raisins and currants (fruit cake) can potentially cause kidney failure in dogs. Many sugar-free candies and gums contain the alcohol-derived artificial sweetener xylitol. It can cause dangerous drops in blood sugar and liver failure in dogs. Chocolate and cocoa contain theobromine, a compound that gives cocoa its bitter taste, which can be highly toxic in dogs and cats. Ingesting a small amount can cause vomiting and diarrhea, and larger amounts can lead to seizures and heart arrhythmias. Fatty meat scraps have been known to cause inflammation in the pancreas, leading to abdominal pain, diarrhea and vomiting. How about our holiday plants???? Poinsettia Plants are very popular at holiday time. Many people believe they are highly toxic to pets, however, while they may cause stomach issues there are 5 popular holiday plants that will certainly cause more discomfort and potential vet bills. The Mistletoe, Holly, Christmas Tree, Lilly and Amaryllis can be extremely hazardous if ingested so please be careful and watch your pets carefully.

WINTER PESTS

Don't make the mistake of thinking that when winter begins pest season ends. Fleas and ticks are a threat year-round. Flea pupae, the last stage of the lifecycle before becoming full grown fleas, can live through a harsh winter in the corners of your home. Ticks and heartworms can also resist the cold, so it's best to keep your pets on a year-round pest treatment program.

LIFETIME LICENSE HOLDERS: Your license privilege tags are sent directly to the last address known by the DEC Fulfillment Center. If you move you must notify the DEC in order for them to correctly mail your license and tags to you. If you have Hunter Education or Bowhunting Education that needs to be added to your account you may edit your profile on-line, bring your original to a DEC License Sales Agent or fax it to (518) 402-9025. Once the information is in your file the appropriate license or tags will be sent to you from the Fulfillment Center. Do not wait until the beginning of the season to take care of this as it will take approximately ten to fourteen days to receive your tags. IF YOU DID NOT RECEIVE YOUR LIFETIME TAGS it means they are sitting in Albany undeliverable. We have had several hunters come in because they did not receive their tags. After contacting the DEC we learned that for whatever reason the tags were returned to them and a mail stop order was placed on the account. If you don't receive your tags a simple phone call to the DEC at (518) 402-8843 will get your account corrected and your tags sent.

cooking with the Clerk's

Kolacky-Polish Christmas Cookies. Yield: about 2-1/2 dozen cookies

Ingredients: 1/2 cup (1 stick = 4 ounces) butter, softened
4 ounces cream cheese, softened
1 cup all-purpose flour
fruit preserves (raspberry, pineapple cherry)

Directions: Beat butter and cream cheese in large bowl with electric mixer at medium speed until smooth and fluffy. Gradually add flour; beat at low speed until mixture forms soft dough. Divide dough ball in half; wrap each half in plastic wrap. Refrigerate 1 hour or until firm. Preheat oven to 375*F. Roll out dough, half at a time, on floured surface to 1/8-inch thickness. Cut into 2-1/2 inch squares. Spoon 1 tsp. preserves into center of each square. Bring up two opposite corners to center; pinch together tightly to seal. Fold sealed tip to one side; pinch to seal. Place 1-inch apart on ungreased cookie sheets. Bake 10 to 13 minutes or until lightly browned. Remove to wire racks; cool completely. Sprinkle with Confectionary Sugar if desired.

Apple Crisp Muffins

Crisp Topping

- 1/2 cup all purpose flour
- 3 Tbsp unsalted butter, softened
- 1/4 cup brown sugar, packed
- 1/4 tsp apple pie spice muffin Mix
- 2 cups all purpose flour
- 3/4 cup brown sugar, packed1 1/2 tsp apple pie spice
- 2 tsp baking powder
- 1/2 tsp baking soda
- 1/2 tsp salt
- 2 large eggs
- 1/2 cup vegetable oil
- 3/4 cup buttermilk
- 2 tsp vanilla extract
- 2 medium apples, peeled and cut in small dice (about 2 cups)

Clerks continued...

- 1. Preheat oven to 350F. Butter a 12-cup muffin tin, or line with muffin liners
- 2. Mix up the crisp topping using your fingers. Rub the butter into the dry ingredients until there is no dry flour left and the mixture has a fine crumbly texture.
- 3. In a large bowl, whisk together the flour, brown sugar, apple pie spice, baking powder, baking soda and salt until everything is fully incorporated. Make sure to blend in any lumps of brown sugar.
- 4. In a separate bowl, whisk the eggs, vegetable oil, buttermilk, and vanilla extract until smooth.
- 5. Add the wet ingredients to the dry ingredients, along with the chopped apples, and fold together gently until there are no dry bits of flour left. Do not over mix at this point.
- 6. Fill your muffin cups quite full, and then sprinkle generously with crisp topping. Note: At this point you can bake right away or let the muffins sit on the counter for an hour. I find this results in a higher rise, but it's optional. If you choose to let the muffins rest for an hour, wait to add the crisp topping until just before baking.
- 7. Bake for about 25 minutes until risen and golden. You can check with a toothpick to see if the center is done if you're unsure.
- 8. Let cool 10 minutes, then remove the muffins to a cooling rack. Enjoy while still warm with a little butter, or rewarm in the microwave for 30 seconds.

SNOW REMOVAL AND WINTER PARKING

The Town of Newfane Winter Parking Ordinance states that no vehicle shall be allowed to park on any Town Highway right-of-way between the hours of 2:00AM to 6:00AM from November 15th to April 1st. The Superintendent of Highways, Jon Miller, shall have the power to cause such removal of all vehicles in violation of this ordinance.

Plowing snow onto public roadways is against the law. Section 1219 of the Vehicle and Traffic Law, and section 214 of the Highway Law of New York State specifically prohibits the placing or leaving of snow, ice or other substance upon any highway (this includes pavement, shoulders, and ditches).

Over the past few years, the practice of plowing or depositing snow from private driveways or private property upon the highway has increased significantly. This practice is taking place even after roadways have been cleared and snow pushed back behind the shoulders by Highway Agencies.

This practice is against the law and serious accidents could result from snow being plowed onto the highway.

All those responsible for plowing or depositing snow upon the highway may be liable for a fine up to \$1,000 per day, per occurrence for each day the situation remains uncorrected.


Police Agencies will be notified of all occurrences with the intent that summonses be issued to all those responsible.

During and after significant snow storms, Highway Agencies receive phone calls regarding damage to mailboxes caused by snowplows or from the force of snow being thrown by the plows. If such damage is caused during snow removal, it is not done intentionally.

There is no statutory or legal authority which grants a property owner along a public highway the right to place a mailbox in a highway right-of-way. The owner must have a mailbox in the right-of-way by law for mail delivery, which may give the owner an informal license. However, this does not give the owner any legal rights in the highway when needed for highway purposes.

When the necessity of keeping the highway open conflicts with the individuals reception of mail, the latter must stand aside. In certain instances, the owner may even be compelled to remove the box under Highway Law #319.

From all of us here at the Highway Department, may you and all of your family have a Merry Christmas and a Happy New Year!!

Effective May 1, 2021 the following rules will be enforced for the town wide brush

Pick-up:

- All branches MUST be piled as neatly as possible with ALL CUT ENDS FACING the road and NO LONGER then 10 ft long.
- Tree removal companies are responsible to remove ALL of their own debris. *****
- We will NOT pick up large stumps, leaves, rubbish, etc.
- A maximum amount of 2 tandem truck loads will be picked up at a time at any one residence.
- We will NOT pick up branches in front of wooded lots that are being cleared.
- We will NOT be responsible for any damages to anything that is under the pile of brush that we cannot see. Large piles are picked up with large machinery.

Niagara County Buck is One for the Record Books By Bill Hilts Jr.

It was a dream come true for Philip Pless of Newfane. On Nov. 8, 2020, the disabled veteran arrowed a huge Niagara County buck that has become the new state record non-typical archery buck. The 210-pound beast, shot in the Town of Newfane, had a green score of 222-6/8 (gross) with a net of 213-7/8 inches. There were 18 scorable points.

The previous non-typical archery record was a 23-point buck taken by Mike Giarraputo of Suffolk County while hunting Nov. 3, 2011. The gross score was 218-4/8 inches, and the net was 210-4/8 after drying out.

What is most impressive about Pless's drop-tine buck is the mass that the rack represents. Don Haseley of Sanborn, the official scorer who measured up the antlers for the official score 60 days later, was impressed by the big deer as he viewed it again at Tim Young's Trophy Room Taxidermy in the Town of Niagara who performed the mount. When it was all said and done, the official measurement was a gross measurement of 221-3/8 and a net score of 214-2/8 inches.

"I always had a dream of shooting a big non-typical drop-tine buck, bow or gun," said Pless. "I'm still on Cloud 9 and can't believe my dream has become a reality."

He was home watching the Buffalo Bills beat up on the Seattle Seahawks with his kids when his wife Elizabeth came home a bit early around half-time of the game. As he sat there contemplating what he should do, he had a feeling in his stomach that he needed to be up in his tree stand. He grabbed his Hoyt Maxxis 31 bow set for a 65-pound draw weight and off he went. He was in his tree stand by 3:15 p.m.

After he was situated in his stand, his wife texted him to see if it was okay to bring the kids over to the farm he was hunting. He said it was fine. However, after he put his phone down, he looked to his left and he saw the big drop tine buck step into the field across from his stand with a doe. He grabbed his phone, took a photo, and texted it to his wife. The text read: "Don't come back. Drop tine is out." With a photo of the buck, no less. It was not the first time that Pless has seen this buck. In fact, he had been following this deer's growth history the last 4 years through trail cam photos. He knew that this buck was special. Some more deer came out, 3 more does.

The original doe came closer to Pless and it appeared that the buck preferred that original female he came out with. As the buck moved closer, he was hoping that the deer would move into range before legal shooting time would end. It was about 4:45 p.m. when he let the arrow fly at 50 yards, hitting it solidly in the shoulder.

"I normally wouldn't shoot anything past 40 yards," said Pless, "but I had purchased a new Trophy Ridge bow sight and I have been practicing with it all summer long out to 70 yards. I was pretty confident that I could get the job done."

Immediately after connecting with the trophy buck, the four does ran up to him and surrounded him. They moved away to a certain point, but he watched the big buck drop about 80 yards away. Pless hesitated climbing out of the stand. He was shaking too much. And he realized he forgot his flashlight.

After calming down, he slowly walked over to where he saw the deer drop. He was gone! He contacted some friends and family who came out to help – Kevin Austin, Scott Pipiles, his brother Jason, and his nephew Connor. It did not take them long to help Pless find his dynamic whitetail. The 210-pound buck was pegged at 5-1/2 years old by Young, with a 33-inch neck.

There was more to the story as far as the family history of taking big bucks. Phillip's grandfather, Clarence Pless of Ransomville (who Phillip never met due to his early passing) shot a big buck in Greenwood, Steuben County back in 1942. It was certified by the New York State Big Buck Club, an 11-point rack that scored 154-7/8. Phillip now has the mount and the certificate thanks to his uncle Glenn Pless of Ransomville. Phillip also has the Ithaca Model 37 12 gauge that he harvested the animal with, documenting a family history for big deer. "I think my grandfather was watching over me when I shot this trophy buck," said Pless.

With the official record designation, Pless has been honored nationally by numerous deer organizations and record-keeping groups. His dream continues....
