TOWN/RESOLUTION NO. 28, 2022/AUTHORIZE DEDUCT CHANGE ORDER #1/CONTRACT NO.21-1/NEWFANE-ONTARIO WATERLINE REPLACEMENT

A <u>MOTION</u> was made by Councilwoman Neidlinger, seconded Councilwoman Rutland to adopt Resolution No. 28, 2022, Authorize Deduct Change Order #1 Contract No. 21-1 Newfane-Ontario Waterline Replacement as follows: Whereas, the Town of Newfane awarded a bid to Rochester Pipeline, Inc. in the amount of \$360,095.00 by way of Contract No.21-1, for the Ontario Waterline Replacement and Whereas, due to the Owner of the project not installing all the quantities, Whereas, Wendel and Rochester Pipeline, Inc. have mutually agreed on the adjustment of bid and change order quantities to match actual quantities installed at the completion of the project, Now Therefore Be It Resolved, that this Board authorizes deduct Change Order No.1 in the amount of \$37,307.71 for a final Contract Price of \$322,787.29.

TOWN/RESOLUTION NO. 29, 2022/JACKSON STREET WATERLINE UPGRADE ENGINEERING AUTHORIZATION/TOWN OF NEWFANE

A MOTION was made by Councilman Coleman, seconded by Councilwoman Neidlinger to adopt Resolution No. 29, 2022 as follows: Whereas, the Town of Newfane will be undertaking the replacement of 1,300 linear feet of waterline along Jackson and VanBuren Street and 2,400 linear feet of waterline along Harrison Street, Lake Street, Beach Street, Wright Street, Lockwood Street, McKee Street and Whereas, the Town desires to retain an engineering firm to oversee the project and provide survey and engineering services; and Whereas, Wendel has submitted a proposal to provide survey and design services for the project at a cost of \$99,700; and Whereas, the services to be provided by Wendel, the Towns retained Town Engineer, are professional services and therefore exempt from the bidding requirements of General Municipal Law; and Now Therefore Be It Resolved, that the Town Board of the Town of Newfane hereby retains Wendel to provide survey and design services for the Jackson Street Waterline Upgrade Project for a time and expense fee of \$99,700 and Be It Further Resolved the Town of Newfane Town Board authorizes and directs the Supervisor to execute any and all documents and take whatever other actions may be necessary to give effect to this resolution.

TOWN/RESOLUTION NO. 30, 2022/RESOLUTION WITH REFERENCE TO THE PROPOSED TOWN OF NEWFANE, NIAGARA COUNTY, NEW YORK JACKSON STREET WATERLINE PROJECT

A <u>MOTION</u> was made by Councilwoman Rutland, second by Councilman Barns to adopt the following resolution Whereas, the Town of Newfane engaged Wendel to complete an engineering report for the Town's Jackson Street Waterline project identifying the current watermain, the system's shortcomings, the proposed infrastructure improvements necessary to improve performance and the projected costs for residents of the Town; and Whereas, affordability for Town residents and property owners is a significant concern in advancement of the proposed projects; and Whereas, the Town is eligible for Drinking Water State Revolving Loan and Grant Funding and the Town desires to submit a completive application to obtain NYSEFC State Revolving Loan Funds and WIIA funding to assist in making the project economically viable to the Town's water users. Now, Therefore, Be It resolved as follows:

- 1. The Town Board authorizes Municipal Solutions, Inc. to prepare an application for Water Infrastructure Improvement Act (WIIA) grant funds and a State Revolving Loan Fund full application from the NYS Environmental Facilities Corporation (EFC) for Drinking Water program funding consideration.
- 2. The Town Board authorizes Supervisor John Syracuse and Mickie Kramp in her role as Town Clerk, to execute the application and any necessary supporting documents required to apply for Water Infrastructure Improvement Act grant funds and the submission of a full application to the NYS Environmental Facilities Corporation (EFC).
- 3. This resolution shall take effect immediately.

TOWN/RESOLUTION NO. 31, 2022/THE TOWN OF NEWFANE DECLARING A PUBLIC HEALTH EMERGENCY PURSUANT TO GENERAL MUNICIPAL LAW § 103(4). TO PURCHASE AND REPLACE A FAILED BOILER LOCATED ON THE WASTE WATER TREATMENT PLANT

A MOTION was made by Councilwoman Rutland, seconded by Councilman Barnes to adopt the following Resolution No. 31, 2022 The Town of Newfane Declaring a Public Health Emergency Pursuant To General Municipal Law §103(4), to Purchase and Replace A Failed Boiler Located On The Waste Water Treatment Plant as follows: Whereas, Town of Newfane Wastewater Treatment Plant, (hereinafter called the WWTP), has an existing boiler that provides heat for the various buildings of the WWTP, and is critical to maintain temperatures for the equipment to operate; and Whereas, the existing boiler unexpectedly failed on July 11, 2022, making the entire treatment plant heating system inoperable, even after repair efforts to make the boiler operational, and Whereas, the WWTP requires the heating system to be operational starting in October or November, depending on the onsite of cold weather, so the replacement of the boiler system is critical to maintain operation of the facility; and Whereas, currently, the WWTP is operating without a heating system, which will not be acceptable during cold weather conditions when the heating system is needed to allow the various plant treatment systems to operate. and whereas, as the heating system at the Newfane WWTP is currently not operational due to the failed boiler, the boiler and heating system replacement must be declared to be an emergency repair and a Public Health Emergency, pursuant to General Municipal Law § 103(4), to bring the system back into operation as soon as possible before cold weather sets in, because:

- 1.) It is unforeseen occurrence or condition.
- 2.) It affects public buildings, public property, or the life, health, safety or property of the inhabitants of a political subdivision or district therein.
- 3.) It requires immediate action which cannot await competitive bidding, and Whereas, pursuant to the Newfane Town Engineer's estimates, an absent this emergency declaration, the Town Engineer Projects that it would take until September at the earliest to receive public bids on the project, and then until November the boiler is ordered, and another 17 weeks before the boiler system would arrive at the WWTP. The subsequent installation of this heating system would extend way beyond the onset of cold weather, thereby endangering the heating system of the WWTP, and creating a danger to the health, safety and welfare of the Community. Now Therefore, It Is Resolved as Follows: 1.) That a public health emergency is hereby declared pursuant to General Municipal Law

- 3.) That the Town will issue a work order for installation of said boiler system to a HVAC contractor, after 2 quotes for said work being obtained by the Town Engineer, to be processed at the August/September Town Board Meeting.

TOWN/ADOPT RESOLUTION NO. 32, 2022/ SELECTION OF INDEPENDENT HEALTH (IHA) AS HEALTH INSURANCE CARRIER FOR NON-UNION EMPLOYEES, TOWN OF NEWFANE (TOWN)

A <u>MOTION</u> was made by Councilwoman Neidlinger, seconded by Councilman Coleman to adopt the following Resolution No. 32, 2022, Selection Of Independent Health (IHA) as Health Insurance Carrier For Non-Union Employees, Town of Newfane (Town) as follows: Whereas, the Town has engaged the services of CH Insurance Brokerage, Inc. (Broker) with an address of The Atrium 100 S. Salina St. Suite 370, Syracuse, NY 13202 to evaluate its employee healthcare benefits and Whereas, after critical review by the Broker, it was determined that by selecting IHA as the newly established carrier the Town would realize premium savings by approximately \$16,400.00 and Whereas, the Town has increased Health Reimbursement Account (HRA) to the employees of \$500 for single and \$1000 for family to help off-set increases in deductibles and co-pays, which may amount to a maximum cost of \$11,500, depending on maximum utilization rates and Whereas, the Town of Newfane stands to realize a net savings to the taxpayer of almost \$5,000.00 and perhaps more based upon utilization of the HRA Now Therefore Be It Resolved that the Town of Newfane hereby selects IHA as the new carrier for the employees.

TOWN/SET PUBLIC HEARING/AMEND THE ZONING MAP

Be it enacted by the Town Board of the Town of Newfane, New York Whereas, 50% of premises known as 6590 Ridge Road, in the Town of Newfane, is currently zoned Residential, under the Zoning Map of the Town of Newfane, dated June 2016, and, Whereas, the Town of Newfane is desirous of rezoning that part of premises to Agricultural/Residential District, since premises is residential and agricultural in nature, and 50% of premises is already zoned Agricultural/Residential, and Whereas, with such rezoning, the premises would then be in conformance with the agricultural and residential character of the areas surrounding the premises, which are zoned A/R on the north and east of the premises, and Rural Residential (RR) on the west, of premises. Whereas, such rezoning will also be in furtherance of the comprehensive master plan of the town of Newfane, would not cause harm to the surrounding properties, and would serve the general welfare of the Town. Now Therefore, It Is Hereby Enacted By The Town Board Of The Town Of Newfane As Follows: The 50% of premises herein as 6590 Ridge Road, Town of Newfane, New York is hereby rezoned from Residential, to Agricultural Residential (AR), and the aforesaid Zoning Map is hereby AMENDED to reflect such rezoning.
