TOWN/RESOLUTION 45, 2022/RESOLUTION BY THE TOWN OF NEWFANE FOR AWARD OF CONTRACT FOR GRINDING OF BRUSH PILE LOCATED AT 1659 PHILLIPS ROAD NEWFANE, NEW YORK

A MOTION made Councilwoman Rutland, seconded by Councilman Coleman to award a contract for grinding of brush pile located at 1659 Phillips Road, Newfane, New York, as follows: Whereas, a large quantity of brush, located at 1659 Phillips Road by the Town of Newfane requires grinding into mulch; and Whereas, the Town of Newfane has requested proposals for the grinding of said brush from 3 contractors, all of which have the specialized equipment to perform this service, and Whereas, the Lardon Construction Corporation submitted the lowest proposal to perform this service for the Town, amounting to \$16,680.00; and Whereas, it is the best interests of the Town of Newfane to accept this proposal from Lardon Construction Corporation and Now, Therefore, Be It Resolved, that the Town Board of the Town of Newfane hereby accepts the proposal from Lardon Construction Corporation in the amount of \$16,680.00 to perform the grinding of the brush located at 1659 Phillips Road in the Town of Newfane, New York.

TOWN/RESOLUTION 46, 2022/ESTABLISHING FEES FOR REIMBURSEMENT TO THE TOWN OF NEWFANE WATER DISTRICT

A <u>MOTION</u> was made by Councilwoman Neidlinger, seconded by Councilman Barnes to adopt the following Resolution 45, 2022, Establishing Fees for Reimbursement to the Town of Newfane Water District as follows: Whereas, the Town of Newfane Water District incurs costs associated with time and material expenses in preparing water and/or sewer inspections including producing compliance letters on behalf of residents who are in the process of selling their homes, and Whereas, The Town of Newfane Water District also incurs costs associated with preparing the re-levying of delinquent water accounts onto the tax rolls, Now Therefore Be It Resolved, that the Town of Newfane hereby adopts the following fee schedule: The sum of eighty-five (\$85.00) dollars for the preparation of a water and / or sewer inspections including the issuance of compliance letters for same, the sum of one hundred (\$100.00) dollars for each delinquent water account that is re-levied onto the tax rolls.

TOWN/RESOLUTION #47, 2022/AUTHORIZING THE TOWN OF NEWFANE, HEREINAFTER CALLED TOWN, TO HIRE JONES, HOGAN AND BROOKS, LLP, ATTORNEYS AND SPECIFICALLY MORGAN L. JONES, JR, ESQ.

A MOTION was made by Councilman Coleman, seconded by Councilwoman Rutland to adopt the following Resolution #47, 2022, Authorizing the Town of Newfane, hereinafter called Town, to hire Jones, Hogan and Brooks, LLP, Attorneys, and specifically Morgan L. Jones, Jr, ESQ., partner in said firm,, to represent the Town in a lease controversy concerning a Lease Agreement, dated 12/28/2006, between the Town and Eugene C. Mazzola, Jr., covering premises known as the Olcott Gazebo Park, Main Street, Olcott, New York. Whereas, the Town has received a notice of an intent from Eugene C. Mazzola, Jr., Lessor to declare the above referenced lease invalid, alleging in that notice, that the Town, Lessee, has breached said and Whereas, the Town has faithfully performed it's obligations under said Lease, and has not breached said Lease, and Whereas, the Town is desirous of hiring Morgan L. Jones, Jr. Esq. and the law firm of Hogan Brooks, LLP, attorneys to represent the TOWN with respect to this matter, and Whereas, it is in the best interests of the TOWN to hire the said Morgan L. Jones, Jr. Esq. and the law firm of Hogan Brooks, LLP, to represent it in this matter, Now Therefore It Is Resolved, that 1.The TOWN hereby hires Morgan L. Jones, Jr. Esq. and the law firm of Hogan Brooks, LLP, attorneys to represent the TOWN with respect to this matter, and do all things necessary to preserve and maintain the TOWN'S interest in said Lease, including litigation, if necessary, at a rate if \$200.00 per hour for any partner of the firm working on his matter, \$150.00 per hour for any associate, and \$125.00 per hour for any paralegal in addition to any costs, fees and disbursements. 2. The TOWN hereby authorizes the Town Supervisor to enter into a representation contract with the said Morgan L. Jones, Jr. Esq. consistent with and in accordance with this Resolution and further authorizes the Supervisor to execute any and all documents necessary to effectuate the provisions of this Resolution.
